Agencies as per provisions of AICTE regulations, the All India Council Technical Education (AICTE) is pleased to accord approval to Pandian Saraswathi Yadav Engineering College Trust, West Perumal Maistry St. Madurai - 625 001 for the establishment of Pandian Saraswathi Yadav Engineering College, Arasanoor Village, Thirumanjialai - PO. Sivaqanai Taluk, Sivaqanai Dist. - 623 560. Tamil Nadu.
